A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, INITIATING AN AMENDMENT TO
FRESNO MUNICIPAL CODE SECTION 15-2760(A)(3) –
TEMPORARY USES NOT REQUIRING A TEMPORARY
USE PERMIT. NONPROFIT FUNDRAISING EVENTS

WHEREAS, Fresno Municipal Code Section (FMC) 15-2760(A)(3) allows nonprofit organizations to hold outdoor events for fundraising purposes without a temporary use permit, so long as the event is for non-commercial purposes and does not directly benefit the establishment where the event is held; and

WHEREAS, FMC Section 15-2760(A)(3) limits sites hosting outdoor events for nonprofit fundraising purposes to no more than three (3) events per year, each event not lasting more than three consecutive days; and

WHEREAS, the Council of the City of Fresno desires to amend FMC Section 15-2760(A)(3) to allow sites hosting outdoor events for nonprofit fundraising purposes to hold events up to (30) days per year, each event not lasting more than three (3) consecutive days; and

WHEREAS, FMC Section 15-5803(A)(1) permits an amendment to the text of the Development Code to be initiated by a resolution of initiation by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council, pursuant to FMC Section 15-5803(A)(1), hereby initiates an amendment of FMC Section 15-2760(A)(3) to allow sites hosting outdoor events for nonprofit fundraising purposes to hold events up to (30) days per year, each event not lasting more than three (3) consecutive days.
