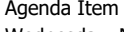

My wife and I are totally against the construction of up to 6 story high-rise, high-density multi family residential building being considered for the vacant lot located at the SE corner of North Brawley and West Beechwood avenues. If this is allowed, there would be negative impacts along Beechwood Avenue from a traffic flow and parking standpoint. The access from Herndon avenue to North Brawley would

be negatively impacted as well. **This vacant lot should be removed from consideration for RM3 developments.** Also, please consider the Sierra Skyport flight paths when evaluating this lot for future projects.

As you might know, we who live in the neighborhood of Herndon and Prospect, have gone through a lot of trouble and anguish fighting off the development on the northeast corner of Herndon and Prospect Aves, which the planning commission and the city council rejected unanimously until a judge rules against the neighborhood wishes.
