AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA, AMENDING THE OFFICIAL LIST OF DESIGNATED SPECIAL SPEED ZONES, PURSUANT TO SECTION 14-1501 OF THE FRESNO MUNICIPAL CODE.

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Under provisions of Section 14-1501 of the Fresno Municipal Code of the City of Fresno, the prima-facie speed limit for the street, or portions thereof, designated in this subsection is hereby determined and declared to be twenty-five miles per hour.
