

**SECOND AMENDMENT TO THE GRANICUS SERVICE AGREEMENT
BETWEEN GRANICUS, INC. AND THE CITY OF FRESNO, CA**

This Second Amendment to the Granicus, Inc. Service Agreement is dated this 30th day of March, 2018, and entered into by and between Granicus, Inc., a California Corporation (Granicus), and the City of Fresno, a California municipal corporation (Client), with reference to the following:

WHEREAS, the Client and Granicus entered into an Agreement dated August 16, 2013 (Agreement); and

WHEREAS, the Agreement was awarded on September 12, 2017, to additional products to the Client's existing solutions; and

WHEREAS, in addition to Client's existing solution, Client wishes to add certain products and services as detailed in the quote dated March 21, 2018, which is attached as **Exhibit A** and incorporated herein by reference.

NOW, THEREFORE, in consideration of the premises, the parties intend that the Agreement be amended as follows:

1. Compensation shall be amended to include an additional one-time fee of Eight Thousand Two Hundred and Twenty-Five Dollars (\$8,475) and Eight Thousand Four Hundred Dollars (\$8,400) per year as detailed in **Exhibit A**. As amended, Client's Granicus solution shall now include additions to the Agreement as detailed in **Exhibit A**. Invoicing for the products and services set forth herein shall commence on July 1, 2018.
2. Except as amended by this Second Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
3. In the event of any inconsistency between the provisions of this Second Amendment and the documents comprising the Agreement, the provisions of this Second Amendment shall prevail.




