**FRESNO CITY PLANNING COMMISSION
RESOLUTION NO. 13486**

The Fresno City Planning Commission, at its regular meeting on September 20, 2017, adopted the following resolution relating to Text Amendment No. TA-17-07:

WHEREAS, on June 22, 2017 the City Council initiated Text Amendment No. TA-17-07 pursuant to Sections 15-2009 subsection F and 15-2010 subsection I of the Fresno Municipal Code (FMC); and

WHEREAS, Text Amendment No. TA-17-07 proposes to allow for an agreement to be established between the City of Fresno ("City") and the owner of a security or electric fence that defends, hold harmless, and indemnifies the City related to the fencing and

WHEREAS, the Planning Commission's scheduled September 20, 2017, hearing on Text Amendment Application No. TA-17-07 was duly noticed by publication in the *Fresno Bee* on September 8, 2017, the newspaper of greatest local circulation; and

WHEREAS, on September 20, 2017, the Fresno Planning Commission conducted a public hearing to consider Text Amendment Application No. TA-17-07; and,

WHEREAS, during the September 20, 2017, hearing, the Commission received and considered the Development and Resource Management Department's report recommending approval of the Text Amendment, and associated environmental documents and provided the opportunity for consideration of testimony from the applicant and the public; and

WHEREAS, no members of the public provided testimony in support or in opposition.

NOW, THEREFORE, BE IT RESOLVED that the Fresno City Planning Commission, based upon information presented at the hearing, finds in accordance with its own independent judgment that there is no substantial evidence in the record to indicate that the text amendment may have a significant effect on the environment as identified by, and evaluated within, the Finding of No Possibility Environmental Assessment No. TA-17-007, dated September 14, 2017.

BE IT FURTHER RESOLVED that the Fresno City Planning Commission finds that the approval of the text amendment is consistent with the adopted Fresno General Plan, and the findings required pursuant to Section 66410 et.seq of the Government Code

BE IT FURTHER RESOLVED that the Fresno City Planning Commission hereby recommends that the City Council approve Text Amendment No. TA-17-07,.
