A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SUBMIT A PROPOSAL REQUESTING REIMBURSEMENT FROM FRESNO UNIFIED SCHOOL DISTRICT (FUSD) FOR PROVIDING AQUATICS PROGRAMMING AT UP TO SEVEN HIGH SCHOOLS IN AN AMOUNT NOT TO EXCEED \$350,000 AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ENTER INTO 2024 AQUATICS RELATED FUNDING AGREEMENTS ON BEHALF OF THE CITY OF FRESNO.

WHEREAS, FUSD and the Parks After School Recreation and Community Services (PARCS) Department have worked together for many years to provide programming to the Fresno community; and

WHEREAS, partnering with FUSD will allow the City to serve more community members as it provides additional opportunities to the community to learn the importance of water safety, become efficient swimmers, and stay cool from the summer heat; and

WHEREAS, FUSD periodically releases a call for proposals to fund extended learning and enrichment programming in the community; and

WHEREAS, the PARCS Department is seeking approval to submit a proposal requesting reimbursement from FUSD for providing aquatics programming at up to seven high schools in an amount not to exceed \$350,000.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
