- c. Tentative Parcel Map No. P24-02812 (TPM No. 2024-08) was filed by Ken Vang, on behalf of Hinds Investments, LLC., pertaining to approximately 17.57 acres of property located on the northeast corner of East Barstow Avenue and North Blackstone Avenue (APN: 418-450-11, 12, 13, 14). The applicant requests authorization to subdivide the subject property into a 8-lot commercial subdivision. No physical improvements are proposed. The subject properties are zoned RMX (Regional Mixed-Use).*

The committee inquired about why the change is requested, how it would affect current tenants, what lots are occupied and what are empty, what the advantages are to divide the parcels.

d. Conditional Use Permit Application No. P24-04037 was filed by Nick Ware and pertains to a tenant space within the existing Hoover Marketplace commercial retail center located at the Southeast corner of East Bullard Avenue and North First Street, 5730 North First Street, Ste 113 (APN 418-030-66). The applicant requests authorization to establish a Type 40 (On-Sale Beer) State of California alcoholic beverage control license for a new 1,260 square-foot karaoke business (That One Place) that will rent private rooms. No lounge or waiting area will be available. The business will operate from 3 pm - 11 pm Tuesday through Thursday and 3 pm - 12 am Fridays and Saturdays. Appointments will be available on Mondays and Sundays up to closing at 11 pm. The parcel is zoned CC (Commercial Community).
