The Engineer's Estimate for this expenditure is \$192,000.00. The contract price is 66% above the Engineer's Estimate. If the overage is greater than 10% or only one bid was received, give explanation:

Staff evaluated the bids and concluded that due to the abundance of available large construction projects at bid time and the relatively low dollar value of this work, this small construction project did not find adequate interest for many typical concrete contractors. Also, with the current COVID-19 (Coronavirus) pandemic and "shelter-at-home" policies and guidelines that are in effect in the state of California, many bidders have raised their bid amounts due to uncertainty. To ensure a successful rebid, staff will reevaluate the scope and update the project's construction estimate in order to be within the adopted project budget. Staff also recommends advertising the project in the fall of 2020 with an anticipation of being beyond the major financial uncertainty of the COVID-19 pandemic. Staff is recommending that Council reject all bids for the Ashlan Avenue Sidewalks project and direct staff to rebid the project.

## **BACKGROUND OF PROJECT:**

The scope of work includes, but is not limited to constructing curb, gutter, sidewalk, drive approaches, minor on-site driveway reconstruction, curb ramp construction, and an Accessible Pedestrian System. This project is on both sides of Ashlan Avenue from Effie Street to SR41.
