RE: Agenda Item ID 21-100--1-M Resolution on A Project Labor Agreement for Citywide Public Work of Improvement Projects.

This is to express the interest of the Southeast Fresno Community Economic Development Association, Inc. (SEFCEDA) in participating in the development and negotiation of the proposed content of a Project Labor Agreement. We believe that this tool should also include the participation of nonprofit organizations that are already involved in the implementation of workforce development programs and have participated in similar agreements with private development projects.
