A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, URGING THE CALIFORNIA BOARD OF PAROLE HEARINGS TO DENY PAROLE FOR

RUDOLPH MARTIN ACOSTA (CDCR #H50445)

WHEREAS, Rudolph Martin Acosta (CDCR Number H50445), currently

incarcerated at Avenal State Prison, was admitted on October 1, 1992, following

conviction for a string of brutal and violent sexual assaults that occurred in the Tower

District and greater Fresno area; and

WHEREAS, over the course of his crime spree, Acosta was connected to at least

nine known victims, with investigators and prosecutors suspecting that the true number

may be higher, based on patterns of behavior and unresolved cases that remain

consistent with his modus operandi; and

WHEREAS, these attacks were not only physically and psychologically

devastating to the individuals directly harmed, but also instilled deep and lasting fear

throughout the Fresno community, particularly in the Tower District, a neighborhood

known for its vibrancy, diversity, and close-knit sense of community; and

WHEREAS, Acosta's crimes were marked by calculated violence, repeated

targeting of vulnerable women, and a disturbing lack of remorse — all of which make him

a continued threat to public safety, should he be released; and

WHEREAS, survivors of these crimes, many of whom continue to live in the Fresno

area, have expressed grave concerns over the possibility of Acosta's parole, citing

retraumatization and the potential erosion of justice they have long fought to uphold; and

WHEREAS, the Fresno City Council remains committed to advocating for victims of violent crime and ensuring that justice, safety, and community welfare remain paramount in decisions regarding parole eligibility for dangerous offenders; and

WHEREAS, allowing parole for an individual responsible for such a prolific and damaging series of crimes would send a dangerous message to both survivors and potential offenders alike — that the severity and lasting impact of such crimes can be diminished over time.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The Fresno City Council strongly urges the California Board of Parole Hearings to DENY parole to Rudolph Martin Acosta (CDCR #H50445), known as the Tower District Rapist, whose numerous violent offenses have left a lasting scar on the Fresno community.
- 2. The Council stands with the survivors, their families, and all residents of Fresno in asserting that the release of such an offender would be not only unjust but also pose a renewed risk to public safety.
- 3. Upon approval, the City Clerk is directed to transmit copies of this resolution to the California Board of Parole Hearings, the Fresno County District Attorney's Office, local victims' advocacy groups, and any other agencies or officials directly involved in the parole process.
