A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE CALIFORNIA TRANSPORTATION COMMISSION'S LOCAL PARTNERSHIP COMPETITIVE PROGRAM CALL FOR PROJECTS TOTALING UP TO \$25 MILLION IN REQUEST FOR FUNDING; AND AUTHORIZING THE EXECUTION OF GRANT APPLICATION AND GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Local Partnership Competitive Program (LPCP) provides grant funds to eligible local agencies for the purpose of rewarding counties, cities, districts and regional transportation agencies in which voters have approved fees or taxes solely dedicated to transportation improvements or that have enacted fees solely dedicated to transportation; and

WHEREAS, the California Transportation Commission administers LPCP and has requested applications from eligible agencies; and

WHEREAS, said procedures established by the California Transportation Commission requires the City of Fresno ("applicant") to certify by resolution the approval of the application before submission of said application to the State; and

WHEREAS, if awarded the City of Fresno desires to apply for LPCP funding and enter into an agreement with the California Transportation Commission and the Fresno County Transportation Authority to receive construction funding for the project.

The Council appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all grant application related documents and execute grant related agreements, subject to prior approval as to form by the City Attorney's Office.

4. This resolution shall be effective upon final approval.
