A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA ACKNOWLEDGING THE RECEIPT OF A REPORT PREPARED BY THE FRESNO FIRE DEPARTMENT RELATED TO THE INSPECTION OF CERTAIN STATE-MANDATED OCCUPANCIES IN THE CITY OF FRESNO AS REQUIRED PER CALIFORNIA HEALTH AND SAFETY CODE SECTIONS 13146.2 AND 13146.3.

WHEREAS, California Health & Safety Code Section 13146.4 was added in 2018, and became effective on January 1, 2019; and

WHEREAS, California Health & Safety Code Sections 13146.2 and 13146.3 require all fire departments, including the Fresno Fire Department, that provide fire protection services to perform annual inspections in buildings used as a public or private school, hotel, motel, apartment house for compliance with building standards, as provided and

WHEREAS, California Health & Safety Code Section 13146.4 requires all fire departments, including the Fresno Fire Department, that provide fire protection services to report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3 and

WHEREAS, the Council of the City of Fresno intends this Resolution to fulfill the requirements of the California Health & Safety Code regarding acknowledgment of the Fresno Fire Department's compliance with California Health & Safety Code Sections 13146.2 and 13146.3.

1. Council expressly acknowledges receipt of and accepts the Fresno Fire Department's compliance report with California Health & Safety Code Sections 13146.2 and 13146.3 in the City of Fresno, as follows:

A. EDUCATIONAL GROUP E OCCUPANCIES

Educational Group E occupancies generally include the use of a building or structure, or a portion thereof, for more than six persons at any one time for educational purposes through the 12th grade.

Within the City of Fresno, there are 250 Group E occupancies. During calendar year 2025, the Fresno Fire Department completed the annual inspection of all applicable Group E occupancies. This is a compliance rate of 100% for this reporting period.

B. RESIDENTIAL GROUP R OCCUPANCIES:

Residential Group R1 and Group R2 occupancies, are generally those occupancies containing sleeping units, and include hotels, motels, and apartments (three units or more).

Within the City of Fresno, there are 2,478 Group R1 and Group R2 occupancies. During calendar year 2025, the Fresno Fire Department completed the annual inspection of all Group R1 and Group R2 occupancies. This is a compliance rate of 100% for this reporting period.
