\*P3a. Description: This Italian Renaissance style home is a full two-stories and rigorously symmetrical. It faces north onto Huntington Boulevard on a .5 acre parcel, which once included tennis courts. The truncated ceramic tile hipped roof has wide overhanging eaves, a boxed cornice and decorative brackets. The front entrance is inset under a portico that is supported by three lonic style columns on each side of the raised porch; fluted pilasters connect the porch to the house façade. The door is recessed and is heavy wood panel, flanked by leaded glass sidelights. The portico has a flat roof with a roof-top balustrade of wood. The ceiling of the porch is beaded wood tongue and groove and is painted a traditional light blue. The matching ribbon windows on the first story façade have a fixed central window with a leaded glass transom above, flanked by matching double hung sash windows; the upper sash of these side windows have true divided lights. Widows on the second story include a set of ribbon widows on each side which match the double hung sash windows on the first floor. A French door leads onto the portico deck roof and is flanked by double hung sash windows as described for the other locations. An external chimney is located on the east side of the home.


Clarence Bernhauer was the Vice President of the Fresno Planing Mill, one of the most prosperous businesses of its kind in the San Joaquin Valley. Bernhauer was born in Rock Island, Illinois in 1886 and came to Fresno with his family as a young child. He entered a partnership with his father in farming and used \$3,000 of his profits to invest in the Mill which was organized by this brother, Arthur W. Bernhauer. He and his wife were prominent in civic affairs. The Bernhauer home is an elegant example of the Italian Renaissance Revival which was reintroduced for residential building in the late 19<sup>th</sup> century and closely replicated the *palazzi* of Northern Italy. The property appears to be eligible for both the California Register and Fresno's Local Register of Historic Resources for its association with the Bernhauer family (Criterion 2, ii, as an excellent example of an architectural style, The Italian Renaissance Revival (Criterion 3, iii) and as an early property and contributor to the proposed Huntington Blvd. Historic District (Criterion i)
