A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO APPLY FOR A GRANT OF UP TO \$500,000 FROM THE CALIFORNIA NATURAL RESOURCES AGENCY (CNRA) TO PROVIDE PROGRAMMING AT CAMP FRESNO FOR UNDERSERVED YOUTH, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN ALL RELATED DOCUMENTS ON BEHALF OF THE CITY. (CITYWIDE) (SUBJECT TO MAYOR'S VETO)

WHEREAS, the CNRA announced the Youth Community Access (YCA) grant program notice of funding opportunity on June 26, 2024; and

WHEREAS, the City of Fresno (City) Parks, After School, Recreation and Community Services (PARCS) Department is seeking authority to apply for and accept funding to support underserved youth with access to natural or cultural resources through Camp Fresno; and

WHEREAS, the City, if successful, will enter into a grant agreement with the CNRA for the implementation of grant funded programming.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Council authorizes the City Manager or designee to apply for up to \$500,000 from the CNRA to fund programming and support access to Camp Fresno for underserved youth with a focus on low-income and disadvantaged communities; and
