# Courthouse Park

## PARK RULES

(for details see Fresno County Ordinance Code, Chapters 13.20 and 13.24)

On Courthouse Park grounds it is **illegal** to:

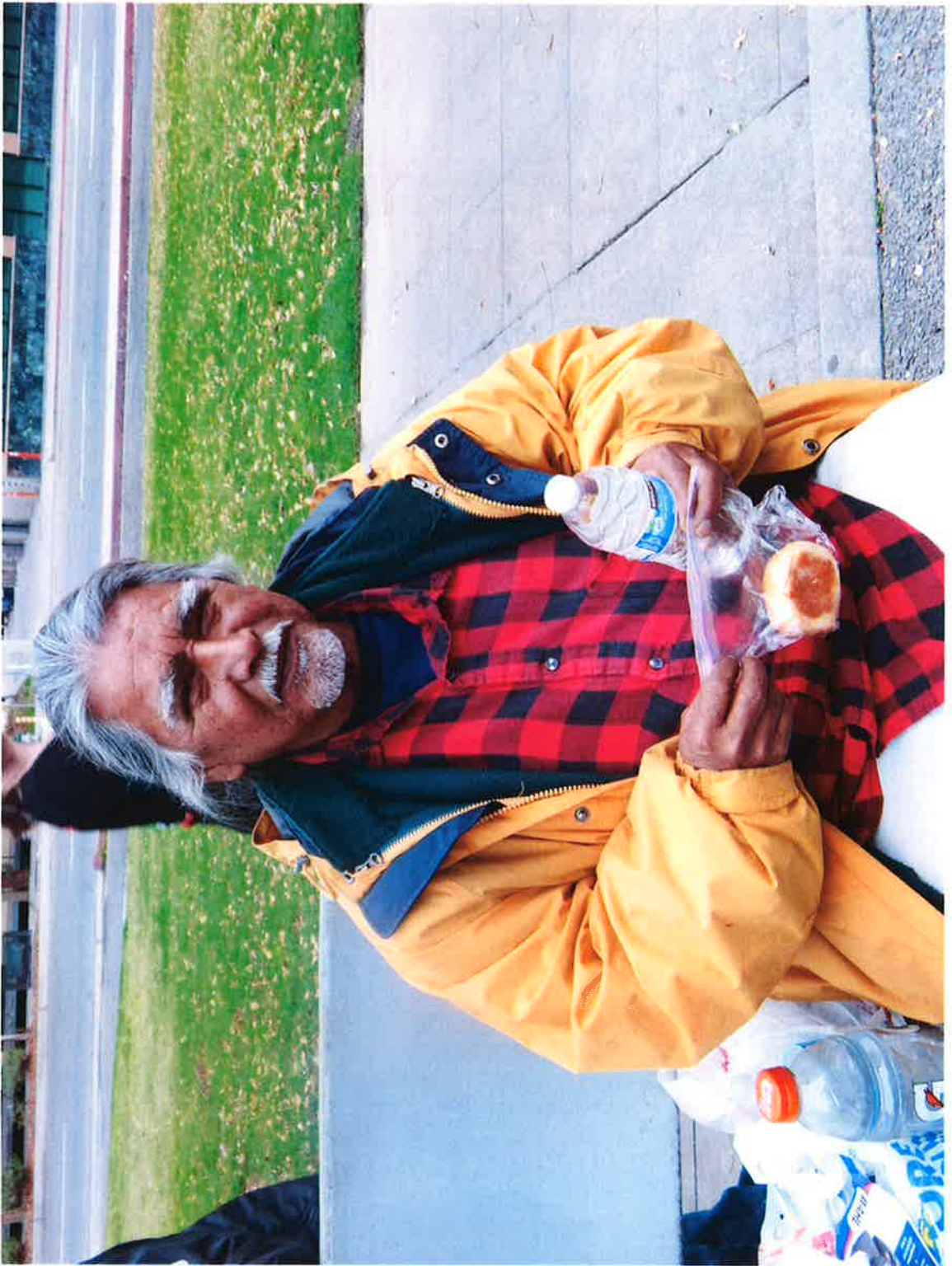
- Possess a mobile container except to pass through the park or as authorized by a permit
- Possess more than 8 cubic feet of personal property, with exceptions specified by FCOC 13.20.060 (e.g., property used for exercise of speech rights)
- Leave personal property unattended
- Camp, erect tents or temporary shelters
- Loiter between 9:00 p.m. and 6:00 a.m.
- Hold a public meeting of 100 or more people without a permit
- Solicit or sell merchandise except pursuant to approval from the Board of Supervisors
- Interfere with government employees' work, through amplified sound or excessive noise
- Use firearms, fireworks or weapons
- Gamble
- Damage turf, shrubbery, vegetation, buildings or property
- Litter (please place all waste in proper trash receptacle)
- Write, print, carve or mark upon any building, benches, sidewalks or property
- Affix signs or notices to buildings, trees or structures or place signs in turf or flowerbeds
- Obstruct the walkways, sprinklers or lights
- Impede the passage of others through building entrances
- Go upon lawn where signs prohibit it
- Allow dogs or pets off-leash (leashes must be 6 feet or less in length)
- Use electrical outlets, except as authorized by a permit

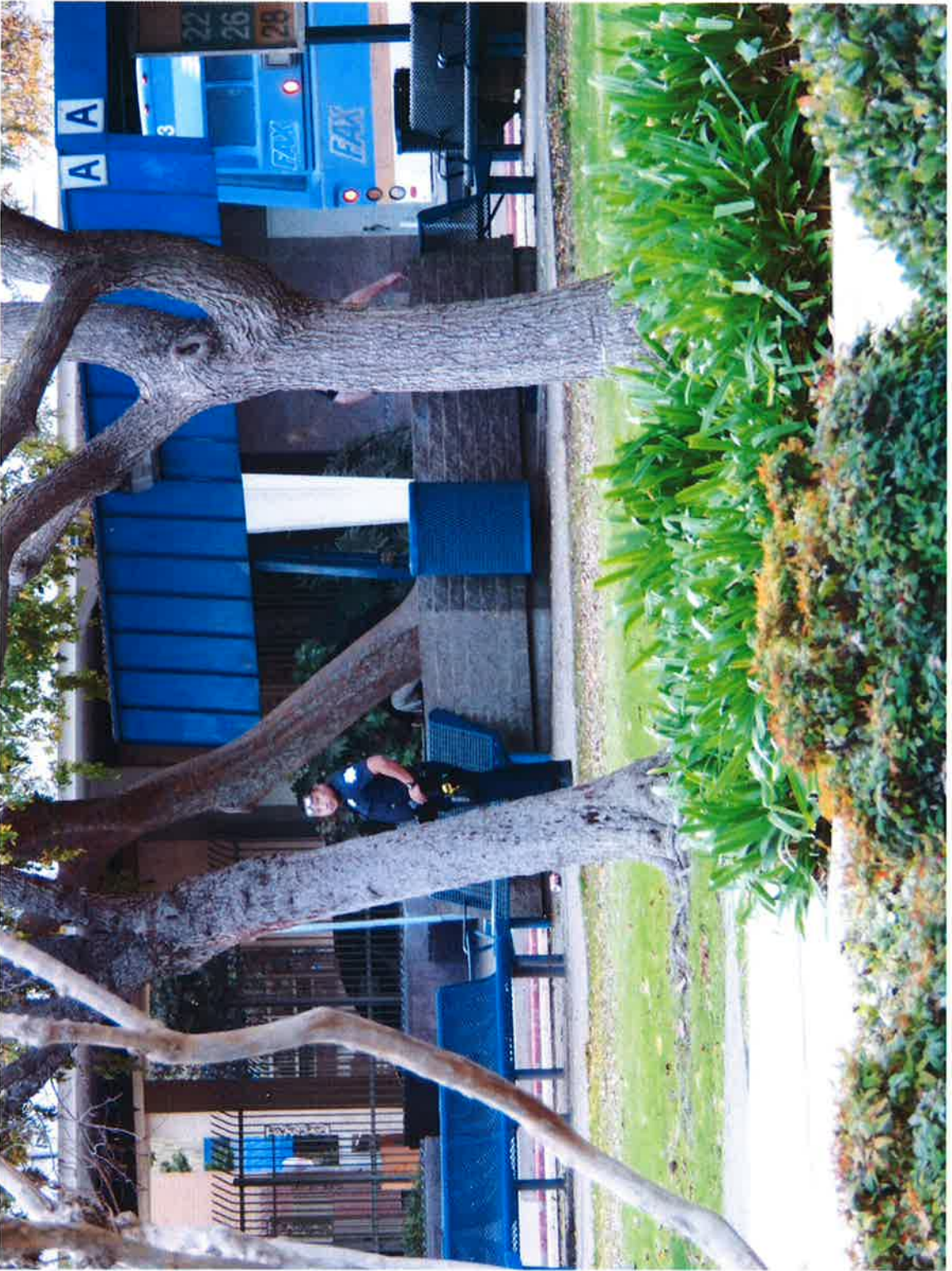
