# THIRD AMENDMENT TO AGREEMENT

THIS THIRD AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this <u>11th</u> day of <u>June</u>, 2021, amends that certain Consultant Services Agreement entered into between the CITY OF FRESNO, a municipal corporation (City), and BKF Engineers, a California corporation (Consultant), dated January 22, 2019 (the Agreement).

# RECITALS

- A. City and Consultant entered into the Agreement for professional engineering services for the design of plans and general construction contract documents for the Mid-Town Trail, Segments 1 and 3.
- B. CITY has reviewed the Segment 3 project, and has determined some project requirements and coordination are beyond the scope of the Consultant Agreement. The City has determined the need for an amendment to the Agreement.
- C. City now desires to modify the scope of work of the Agreement to address the out-of-scope requirements and additional coordination. The City now desires provide payment thereof in the amount of \$58,418.23 to the Consultant.

### AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual premises herein contained, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. Consultant shall provide additional services as described in **Attachment "A"**, attached hereto and incorporated herein by reference. Such additional service shall commence upon execution of the Third Amendment to Agreement by both parties, and shall end upon termination of the Agreement.

2. Consultant's sole compensation for satisfactory performance of all services required or rendered pursuant to this Amendment shall be a total fee of \$58,418.23. The \$58,418.23 is accounted for in the FY2021 budget.

3. In the event of any conflict between the body of this Amendment and any Exhibit or Attachment hereto, the terms and conditions of the body of this Amendment shall control and take precedence over the terms and conditions expressed within the Exhibit or Attachment. Furthermore, any terms or conditions contained within any Exhibit or Attachment hereto which purport to modify the allocation of risk between the parties, provided for within the body of this Amendment, shall be null and void.

4. Except as otherwise provided herein, the Agreement entered into by City and Consultant, dated January 22, 2019, First Amendment, dated February 2, 2021, and Second Amendment, dated February 12, 2021, remain in full force and effect.
