### Dear Property Owners and Ratepayers:

This notice explains the proposed residential solid waste rate update for customers receiving residential solid waste services from the City of Fresno (City). In accordance with Article XIII D of the California Constitution, the City is providing this written notification to owners of record and customers of record that receive, and/or pay for residential solid waste services provided by the City. Specifically, this notification describes proposed changes to the schedule of rates charged for residential solid waste services.

The City will conduct a public hearing on the proposed changes to the schedule of rates, fees, and charges for residential solid waste services at the date, time, and location specified below. At the public hearing, the Fresno City Council will consider all protests against the proposed rate changes. If, on or before the close of the public hearing, written protests against the proposed rate update are presented by a majority of parcels that receive residential solid waste services, the City Council will not enact the proposed rate plan. If less than a majority of parcels receiving residential solid waste services submit written protests against the proposed changes, the City Council may consider the proposed rate plan, and if adopted, it will become effective on July 1, 2024. The City will accept protests from both owners and customers of record, but only one protest per parcel will be counted.

### Background

The Solid Waste Management Division (Division) of the Department of Public Utilities (DPU) provides weekly solid waste (refuse), recycling, and green waste/organic material collection services plus an annual Operation Clean Up bulky item curbside pickup service to over 119,000 residential customers in the City of Fresno (City).

With a fleet of over 176 trash and support service vehicles, 103 Sanitation Operators travel approximately 1.3 million miles and make more than 18 million stops to collect over 255,000 tons of

solid waste, recycling, and green waste/organics material every year.

The Division also provides the following community services:

- Operation Clean Up, the annual bulky items collection service for residential customers
- Free Dump Days on six weekends per year at the Cedar Avenue Recycling and Transfer Station
- Free Shred Events three times per year
- Litter control activities
- Recycling education and outreach

Finally, the Division is responsible for post-closure monitoring and maintenance activities at the Fresno Sanitary Landfill.

### **Reasons for the Proposed Changes**

To continue providing residential solid waste services to customers at the current level of service, rate updates are needed to cover increasing operational costs and reestablish the Division's financial health.

The Division's proposed rate updates for residential solid waste collection service cover the five-year period from Fiscal Year (FY) 2025 through FY 2029 and are intended to maintain service levels while meeting projected expenditures for operating and capital expenses and replenishing operating reserves to achieve the necessary requirements. The proposed rate changes reflect the cost of providing service to each customer based on 96-gallon container service and/or 64-gallon container service.

The rate increases are needed to cover increasing operational costs since the last increase was implemented on September 1, 2009. Contributing factors include rising costs of collection vehicles, fuel, vehicle maintenance, landfill tipping fees, labor, collection containers, and Fresno Sanitary Landfill post closure operating and capital costs. In addition, the City has incurred new costs to comply with the regulatory mandates of Senate Bill (SB) 1383, which requires the integration of food waste into the green waste/organic material collection container, recovery of edible food waste, outreach and education activities, monitoring, and enforcement. Also, there is the addition of a new service for one bulky item curbside collection per year for each residential customer by appointment beginning in FY 2026.

The proposed capital plan for FY 2025 through FY 2029 totals \$92.3 million and includes the following projects:

1. Replacement of the Division's aging vehicle fleet = \$69.3 million (25.4 percent of the cumulative rate update)
2. The Division's portion of the DPU O&M Facility improvements = \$5.6 million (2.1 percent of the cumulative rate update)
3. Collection container purchase and maintenance activities = \$5.2 million (1.9 percent of the cumulative rate update)
4. Post-closure improvements and maintenance at the Fresno Sanitary Landfill = \$4.6 million (1.7 percent of the cumulative rate update)

## **Basis for Calculating Proposed Changes**

In developing a five-year schedule of rates, the City must comply with Article XIII D of the California Constitution by establishing rates that recover the actual costs associated with the level, quality, and quantity of service delivered to each customer class. Accordingly, the City's proposed five-year schedule of rates is based on common and well-established cost-of-service principals that promote equity among system users, whereby users of the utility service pay rates that are directly proportional to the level, quality, and quantity of service they receive.

An independent rate consultant designed a five-year schedule of rates to recover the Division's five-year forecast of capital, operations, and maintenance expenditures for residential solid waste services. The methodology used to develop the recommended residential solid waste rates is based on the principle that a utility's full revenue requirements should be equitably recovered from customers in each service level in proportion to the cost of serving those customers. The proposed rate plan complies with the California Constitution by establishing rates that recover the actual costs associated with the level, quality, and quantity of services delivered to individual users of the utility.

The rate study involved three levels of analysis – the development of revenue required from rates, allocation of revenue requirements among functional (operational) cost categories (cost-of-service analysis), and design of a rate structure.

The revenue requirement for residential solid waste rates was allocated so that revenue from rates for each service level (by material type, (i.e. solid waste, recycling, and green waste/organic waste) was sufficient to cover the costs of providing the services in total and by container size. The rate structure uses the costs by container size for each material type to determine rates that are proportionate for the customers in each customer class.

Based on the results of the cost-of-service analysis, it was determined that the individual residential service rates for FY 2025 need to be realigned to maintain proportionality among service levels. As such, the change in rates is different for each service level for FY 2025. Once realigned, the rate adjustments will be applied equally to all service levels each year from FY 2026 through FY 2029.

There are two options to protest the proposed rate update:

1. **Protest Card:** The City of Fresno (City) has enclosed a protest card with this notification that can be returned to the City in the provided prepaid reply envelope.
2. **Alternate Written Protest:** While the protest card provided by the City is the easiest and simplest way to submit a protest, other forms of written protest are acceptable. An alternate written protest that is submitted will only be counted if it includes **all** the following components:
  - a. States the submitter's intention to protest the residential solid waste rate update;
  - b. Identifies the APN, street address, or utility account number(s) of the parcel with respect to which the protest is being made;
  - c. Includes the name of the record owner or tenant ratepayer that is submitting the protest; **and**
  - d. Includes the original signature of the record owner or tenant ratepayer that is submitting the protest.

Protest cards and alternate written protests must be received by the City Clerk's Office at 2600 Fresno Street, Fresno, CA 93721 by 5:00 P.M. on May 2, 2024, or submitted before the close of the public hearing. Only protest cards received before the close of the public hearing on May 2, 2024, will be counted. No emailed or faxed protest cards will be accepted.

The City rescheduled the public hearing to June 20, 2024 to provide all owners and customers of record this notice at least 45 days prior to the public hearing at which the rates will be considered.
