NOTICE IS HEREBY GIVEN that the Fresno City Council, in accordance with Fresno Municipal Code (FMC) Section 15-4902, 15-5007, and 15-5812, and in accordance with the procedures of Article 50, Chapter 15, of the Fresno Municipal Code, will conduct a public hearing to consider the items below, filed by Bonique Emerson of Precision Civil Engineering, Inc., on behalf of Ryan Lancer of Buzz Oates Management Services, which pertains to approximately 55.31 acres of property located on the southeast corner of East Annadale and South Elm Avenues.

1. **Environmental Assessment No. P23-03006**, dated February 20, 2025, an Addendum to Final Program EIR (SCH No. 2017031012) for the Southwest Fresno Specific Plan for the proposed project pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15164; and
2. **Plan Amendment Application No. P23-03006**, proposing to amend the Fresno General Plan and the Southwest Fresno Specific Plan to change the planned land use designation of the subject properties from Neighborhood Mixed-Use to Employment – Light Industrial and amend Policy LU-8.1 of the Southwest Fresno Specific Plan.
3. **Rezone Application No. P23-03006**, proposing to rezone the subject properties from the NMX (*Neighborhood Mixed-Use*) zone district to the IL/cz (*Light Industrial/conditions of zoning*) zone district.

The Fresno City Planning Commission considered the applications at its meeting on April 16, 2025, and voted to recommend denial of the applications.

NOTE: This public hearing notice is being mailed to surrounding property owners and residents within 1,000 feet of the project site pursuant to the requirements of FMC Section 15-5007.

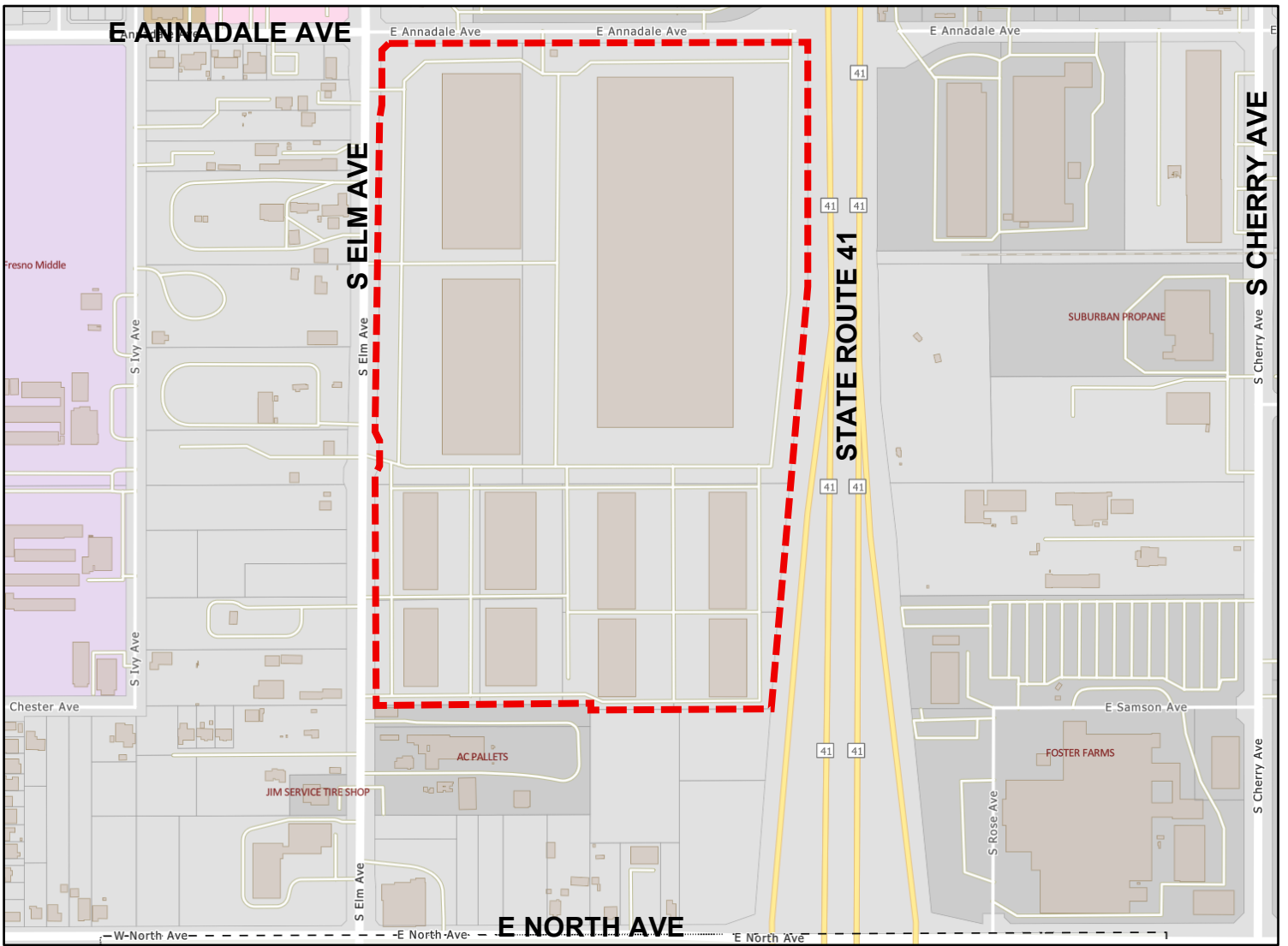
