

FIRST AMENDMENT TO CONTRACT

THIS FIRST AMENDMENT TO CONTRACT (Amendment) made and entered into as of this 30th day of June 2025, (Effective Date) amends the Contract entered into between the CITY OF FRESNO, a California municipal corporation (City), and Tetra Tech BAS, Inc., a California Corporation (Contractor).

RECITALS

WHEREAS, the City and Contractor entered into a Contract on October 1, 2024, (Contract), to perform or cause to be performed, in a good and workmanlike manner, under the direction and the satisfaction of the City's "Engineer", and in strict accordance with the Specifications, all of the work as set forth in the Contract documents for a total fee of \$611,679; and

WHEREAS, the City and the Contractor desire to extend the Contract to December 31, 2025, to complete the Project; and

WHEREAS, with entry into this Amendment, the Contractor agrees that it has no claim, demands, or disputes against the City.

AGREEMENT

NOW, THEREFORE, the City and the Contractor agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made part of this Amendment.
2. The Agreement is extended to December 31, 2025.
3. The number of working days allowed for the Contractor to complete all services from the authorization to proceed is extend by 184 calendar days to 945 calendar days.
4. Except as otherwise provided herein, the Contract entered into the by the City and the Contractor on October 1, 2024, remains in full force and effect.


