A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ADOPTING THE 530<sup>th</sup> AMENDMENT TO THE MASTER FEE SCHEDULE RESOLUTION NO. 80-420 TO ADD AND DELETE VARIOUS WATER CONNECTION FEES

NOW IT THEREFORE, BE RESOLVED by the Council of the City of Fresno that:

1. The Master Fee Schedule Resolution No. 80-420 be and is hereby amended to add and delete various water connection fees. The revised pages of the Master Fee Schedule are attached as Exhibit "A" and are hereby incorporated by reference and made a part of this Resolution.
2. Effective July 1, 2018, staff shall administratively update the Water Capacity Fee added by this resolution annually based on the percentage change in the 20-City Construction Cost Index as reported in the Engineering News Record (ENR) for the 12-month period ending in May of the year of adjustment.
3. The fees adjusted by this Resolution shall become effective on the effective date of Ordinance NO. 2016-\_\_\_\_\_ [An Ordinance of the City of Fresno establishing and setting a schedule for Water Capacity Charges under the Mitigation Fee Act, and amending Article 5 of Chapter 6 and Article 4.5 of Chapter 12 of the Fresno Municipal Code].
