Nomination Statement

Over the summer I (Desjanee Threat) have had the pleasure of interning at Resources for Independence Central Valley (RICV). I am a Fresno State student and intern for RICV through the Community Service Scholarship and Humanics program at Fresno State.

Before applying for the internship I didn't know who RICV was, being honest. While getting ready for my interview I did research on their website and Facebook page to learn about the organization. I was extremely impressed and eager to become the intern at such a great organization, which plays such an important part in the community. Resources for Independence Central Valley's Mission is "Encouraging people with disabilities to be in control of their lives and live more independently through a diverse range of choices and opportunities." Resources for Independence Central Valley is a nonprofit organization that serves people with disabilities.

As an intern I realize the importance of what they do. I am interning under the System Change Advocate Charity Tokash. I was able to go with Charity to legislative office visits and see her communicate with the legislative staff about what's going on at RICV. RICV is all about building relationships with the community and community involvement. I learned that RICV serves approximately 2,000 consumers with disabilities yearly. The population of people with disabilities served varies from: cognitive, hearing, physical, vision, mental/emotional, and other.

RICV offers many programs for people with disabilities.

BRIDGES is youth transition program that targets youth with disabilities and helps youth development. A community based program that is designed to assist high school students with physical or learning disabilities transition from the safety of the school environment to the more complex working world, educational environment, and/or adulthood.

Freedom to Ride is a program that helps people with disabilities learn independent and safe travel on the public transit system.

Creative Careers is a program that helps people with disabilities with finding independence through employment.

Independent Living Specialist (ILS) core services provides information and referral, individual advocacy, goal attainment planning, housing, employment and education resources and independent living skills training.

These are just a few of the programs and services that RICV offers for people with disabilities. RICV also helped with the development of Inspiration Park, a park that is made with people with disabilities in mind. RICV also has the Community Leadership Academy (CLA) which is a governance course that prepares people who want to serve in community leadership roles as board, council, and committee members serving local government and non-profit organizations.

Resources for Independence Central Valley since 1976 has been a nonprofit organization dedicated to serving people with disabilities. At least 51% of RICV's staff and Board of Directors have disabilities, representing the population RICV serves. While doing my internship here throughout the summer I've seen staff that love their job and put their blood, sweat, and tears into it. RICV staff has great relationships with the consumers that they serve. This is why I'm nominating RICV for the 2017 Achievement Award.
