- b. Razor Wire Text Amendment Application P23-01018. This project pertains to a citywide Text Amendment and will be updating Section 15-2009 of the Fresno Municipal Code to allow razor wire in certain circumstances.

- c. Text Amendment Application No. P24-01100 proposes to amend the Citywide Development Code and modify Section 15-2706; otherwise known as the Responsible Neighborhood Market Act (RNMA). The RNMA provides regulations relating to the establishment of alcohol licenses and the sale of alcoholic beverages for off-site consumption. The proposed text amendment would allow flexibility for full-service grocery stores seeking to operate by allowing an additional exception to the Location Restrictions and an exemption to the Cancel & Transfer Provisions. In addition, the proposed text amendment defines Full-Service Grocery Store and its exclusions.

- d. Conditional Use Permit Application No. P23-04343 was filed by Philip Decker of SAC Wireless on behalf of Verizon Wireless and pertains to a portion of the ± 0.5-acres located at 442 E TWAIN AVE (C/T) FRESNO, CA 93710. The applicant proposes to construct an 80'-0" monopine cell tower with: (6) panel antennas; (3) air antennas; (2) microwave antennas; (9) radios; and other ancillary equipment necessary for operation. The applicant also proposes a 900 square foot ground compound with: 8'-0" CMU wall; (1) PG&E transformer; (1) 30kw diesel generator; (3) cabinets; and other ancillary equipment necessary for operation. The parcel is zoned CMX/cz.
