The design phase of the project was initiated in FY20 when the City was awarded a state grant from the Active Transportation Plan (ATP). The grant funds were obligated and the project was budgeted in the adopted FY 20 Capital Budget by City Council. The design commenced following Council approval. The preliminary engineering design and project management took approximately two years.

The scope of the project includes the installation of a High Intensity Activated Crosswalk along the McKenzie Trail as it crosses Peach Avenue and a slight modification to the existing roadway signing and striping to better present the presents of pedestrians in the vicinity. These proposed improvements will create a positive impact for all trail users by improving the safety of this trail crossing a major street. Public Woks staff performed all necessary survey and engineering work and prepared the construction documents for the project.
