This project received three viable bids, all of which exceeded the expected construction costs. While the low bid tracks with recent traffic signal bids, all of which have exceeded the engineer's estimates for a variety of reasons, including COVID-related materials and labor shortages in addition to the abundance of electrical work in the Central Valley.


