Discussions between the General Services Administration (GSA) and Benchmark Solutions, LLC regarding the proposal submitted in response to solicitation 47QSMD20R0001 (Refresh 02, June 10, 2020) for an IT Schedule 70 Award, have concluded. Your Final Proposal Revision is subject to the Late Submissions, Modifications, and Withdrawals of Proposals provision of this solicitation. Your offer may be rejected if you fail to meet the timeframe established. The Government intends to make award without obtaining further revisions. The FPR must be signed by the person authorized to sign the offer and must include, for comparison purposes, the following elements:

- 1. Benchmark Solutions, LLC takes the following exceptions to the terms and conditions of the contract: **None**.
- 2. The following Special Item Numbers (SINs) were proposed: **SIN 511210**
- 3. Benchmark Solutions, LLC confirms that the EPA clause for the Base Period and Option Periods will be under clause 552.216-70, based on a commercial pricelist.

Benchmark Solutions, LLC confirms that the following chart reflects all agreed upon pricing, whether accepted as proposed or negotiated. The data also includes other proposed or negotiated discounts, e.g. volume discounts, prompt payment terms, etc. Benchmark Solutions, LLC understands that the Industrial Funding Fee must be set aside for remittance to GSA on a quarterly basis. The Industrial Funding Fee (IFF) is a separate collection mechanism and any increase or decrease in the fee does not change the price discount relationship stated above. The current IFF is .75% and should be calculated as follows:

Negotiated price divided by (1 minus .0075) which equates to Negotiated price divided by 0.9925. Example: (\$100,000 / 0.9925) = \$100,755.67
