BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment): The First Street Class IV Bikeway project was initiated in FY20 when the City of Fresno was awarded grant funding through Caltrans' Active Transportation Program (ATP) to promote active modes of transportation, including biking and walking, throughout the state by funding capital projects which improve these types of facilities. Public Works staff designed the project to provide Class IV protected bikeways along First Street, from Tulare Street to Hazelwood, as the southerly leg of the First Street protected bikeway corridor, identified as a north-south route for a Class IV facilities in the Class IV feasibility plan. Staff initiated design in FY21 and completion of the plans and specs took approximately 18 months. This project is funded by the State of California's ATP grant with the required local match funded through Local Measure "C" Bike Facilities and the SB1 Road Maintenance and Rehabilitation Account (RMRA).
