A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, ADOPTING THE TRAVEL BY  
TRAIL, FRESNO! TRAIL NETWORK WAYFINDING,  
PROMOTION AND CONNECTIVITY PLAN

Whereas, the Council of the City of Fresno (Council) adopted the Fresno Active Transportation Plan (ATP) on March 2, 2017, as a comprehensive guide outlining the vision for active transportation in the City of Fresno (City);

Whereas, the ATP identifies over 166 miles of Class I trails as part of the recommended active transportation network, designed to serve human-powered travel including walking, bicycling, and wheelchair use;

Whereas, utilizing Caltrans Sustainable Transportation Planning Grant Program grant funds, the city engaged a consultant to prepare the Wayfinding Plan for Fresno's Trail network as well as promotional material, community outreach and ensuring consistency in trail wayfinding to neighboring jurisdictions; and

Whereas, the consultant completed a comprehensive wayfinding plan, Travel by Trail, Fresno! Trail Network Wayfinding, Promotion and Connectivity Plan attached hereto as Exhibit A, to ensure trail segments converge into a well-connected route helping residents overcome first-mile and last-mile challenges, by maximizing multimodal connections between trail and transit and encouraging residents to walk.
