# Legal Responsibility of the City

- The City is required to maintain or provide for the maintenance of a pound system and a rabies control program. (Health & Safety Code §121690(e))
  - This mandate includes responsibilities to quarantine rabies-suspect animals or destroy the animal(s) at the discretion of the Health Officer,
  - Distribute anti-rabies vaccine,
  - Investigate reports of rabies (bite investigations),
  - Enforce dog licensing and rabies vaccination requirements
  - Provide dog vaccination clinics with no excess costs passed on to clients.



# Legal Responsibility of the City

- The City is required to provide for the impound of all dogs found running at large and for killing in a humane manner, or otherwise disposing of dogs which are impounded. (Food & Agric. Code §31105).).
  - Animal control shall exercise rights to retrieve animals that have been involuntarily deposited (Civil Code §1815 and §1816)
  - Take possession of stray, abandoned, neglected animals and care for the animal until it is redeemed by the owner or claimant. (Penal Code §597.1; §597f)
  - Shelters shall provide animals with prompt veterinary care, nutrition, shelter, and treat them kindly. (Civil Code §1834)
  - No adoptable animal shall be euthanized if it can be adopted into a suitable home. (Civil Code §1834.4)

- ROI maximized over long term.



# Project Milestones: Now – September 2022

- Employee, equipment and supplies acquisitions with FHAS input.
- Training, learning and ramping up toward operations.
- Establishing operating protocols based on current best practices and with expert partner input (UC Davis Koret Shelter Medicine Program and Best Friends Animal Society).
- Initial phase of an outreach educational plan introducing the new operating process.
- Reviewing implementation of operations to collaboratively determine City and FHAS roles.
- Data collection to evaluate new programming and operational costs of new facility.
- Variable reimbursement to FHAS based on actual costs incurred.

# Project Milestones: Oct. 2022 – June 2023

- Return to Council to provide updates of the previous months of operations.
- Revisiting learned lessons arising from transition period.
- Evaluating and refining data to ensure accurate cost analysis to determine actual operating costs.
- Refining accountability and oversight measures this includes the City having full access to the animal data management system.
- Updating scope of work and respective budget in alignment with proven best operating practices.
- Seeking outside funding opportunities and grants both by FHAS, City and other entities.
- Variable reimbursement to FHAS based on actual costs incurred.

# **Upcoming Agreement**

- Term 14 months
- Collaborative approach to all aspects that allows use of available resources by the City and FHAS
  - Employee recruitments including temporary employees.
  - Acquisition of equipment, vehicles and ancillaries.
  - FHAS to use existing contracts requiring veterinarians for pharmaceuticals and consumables.
  - Proactively recruit and plan for veterinary clinic operations.
  - Reimbursement on actual costs to FHAS.
    - Monthly P&L statement audits review and approval of reimbursement by City.

## **Future Agreements**

 May 2023 return to Council with a fully evaluated program based on proven data and phased in achievable outcomes that include updates to Municipal Code & Master Fee Schedule and a budget reflective of the real operational need.
