WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires jurisdictions that receive federal entitlement program funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant - Coronavirus (CDBG-CV) Program funds; and

WHEREAS, on May 2, 2019, the Council of the City of Fresno adopted Resolution 2019-096, approving the City of Fresno (City) FY 2019-2020 Annual Action Plan; and

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act),
Public Law 116-136, directed HUD to allocate additional entitlement funds to prevent,
prepare for, and respond to the coronavirus (COVID-19); and

WHEREAS, HUD allocated CDBG-CV1 funds of \$4,184,132 and CDBG-CV3 funds of \$3,795,954 for a total of \$7,980,086 to the City to prevent, prepare for, and respond to COVID-19; and

WHEREAS, HUD has issued a waiver allowing the City to amend its Citizen Participation Plan to conduct a five-day public comment period; and

WHEREAS, the five-day public review and comment period began on April 1, 1 of 3
