WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) Program funds; and

WHEREAS, in Fiscal Year (FY) 2023, the City of Fresno (City) is expected to receive over \$12.7 million from these funding sources; and

WHEREAS, the City conducted a Consolidated Notice of Funding Availability (NOFA) process to identify qualified activities to meet the project objectives as outlined in the 2022-2023 Annual Action Plan for Homeless and Homelessness Prevention Programs; Community Services Programs; and Infrastructure and Facility Improvements; and

- 4. The City Manager is authorized to sign all reasonably required or implicated documents, instruments, and funding agreements, and subrecipient agreements in pursuit hereof, subject to prior approval as to form by the City Attorney's

Office.
