The project received five bids for the South Orange Avenue and East Central Avenue Intersection Improvement Project and all five bids were above the engineer's estimate. There are a number of factors that contributed to the higher than expected bid prices. One of the main reasons identified is that this project requires coordination with FID and the contractor must complete the work within FID's dry season timeline. The limited construction window imposed by FID may require the contractor to pay premium labor and material cost to complete the work. Furthermore, the construction industry is also experiencing significant cost increases for material and labor along with long delays for material acquisition. Given the current market conditions and market uncertainty, staff is recommending awarding the project.
