A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ESTABLISHING A POLICY FOR CITY COOLING AND WARMING CENTERS

WHEREAS, according to the CDC and National Weather Forecast, extreme temperatures could lead to weather related illnesses, including heat strokes, dizziness, heat exhaustion, hypothermia, frostbite, long term health conditions, and loss of life; and

WHEREAS, the City of Fresno has been experiencing an increase in heat waves over the last few years, with record-breaking numbers of days with temperatures of 100 degrees or greater; and

WHEREAS, the surge in wildfires has intensified already life-threatening health conditions; and

WHEREAS, individuals most impacted by extreme weather changes are our most vulnerable communities, including but not limited to, individuals and families experiencing homelessness, non-English speakers, families earning low incomes, and individuals residing in highest-needs neighborhoods with lack of tree shade canopies; and

WHEREAS, families continue to face increasing financial burdens of rising energy costs, while many living units are not adequately equipped with proper functioning cooling and warming systems; and

WHEREAS, the National Weather Service provides critical tools for excessive heat event mitigation plans, including an Excessive Heat Watch when conditions are favorable for a n excessive heat event and in the next 12 to 48 hours, and an Excessive Heat Warning/Advisory when an excessive heat event is expected in the next 36 hours; and

WHEREAS, the Council desires to establish a policy with respect to the activation and operation of its cooling and warming centers.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. Cooling centers shall be activated any time the temperature is forecasted to reach 100 degrees. Operating hours shall be from 12:00 p.m. to 8:00 p.m. The City shall provide access to drinking water for those utilizing the cooling center. At minimum, cooling centers shall be provided at Maxie L. Parks Community Center, Ted C. Wills Community Center, Mosqueda Community Center, and Pinedale Community Center. The City Manager shall work to identify additional locations across the City to increase access to cooling centers.
- 2. Warming centers shall be activated any time the temperature is forecasted to drop below 35 degrees. Operating hours shall be from 7:00 p.m. to 7:00 a.m. At minimum, warming centers shall be provided at Maxie L. Parks Community center, Ted C. Wills Community Center, Mosqueda Community Center, and Pinedale Community Center. The City shall provide essential resources such as cots and blankets to participants. The City Manager shall work to identify additional locations across th City to increase access to warming centers. Locations shall comply with applicable standards under state and local law, including the California Building and Safety Code.
- 3. The City shall provide notice through all City communication platforms and notice shall be given to all Council offices 72 hours to activating cooling centers and 24 hours prior to activating warming centers.

- 4. The City's Transportation Department (FAX) shall provide free bus transportation to its cooling and warming centers whenever they are activated.
- 5. The City shall work to accommodate the transport of individual's pet(s) consistent with local, state, and federal laws and regulations.
- 6. Should additional appropriations be required to operate cooling and warming centers consistent with this Resolution, the City Manager shall place an item on a City Council Agenda to request such appropriations.
 - 7. This resolution shall be effective upon final approval.
