A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE PLANNING AND DEVELOPMENT DEPARTMENT DIRECTOR TO UPDATE THE TEXT, POLICIES, MAPS, TABLES, AND FIGURES CONTAINED IN THE WEST AREA NEIGHBORHOODS SPECIFIC PLAN DOCUMENT TO REFLECT THE FINAL ACTION TAKEN BY CITY COUNCIL, TO THE EXTENT THAT SUCH UPDATES ARE NECESSARY TO MAINTAIN CONSISTENCY

WHEREAS, on August 18, 2022, the Planning Commission of the City of Fresno considered the West Area Neighborhoods Specific Plan and Final EIR SCH No. 2019069117 and recommended approval of the same to the Council of the City of Fresno; and

WHEREAS, on August 18, 2022, the Council of the City of Fresno heard staff presentations and public comment regarding the West Area Neighborhoods Specific Plan and Final EIR SCH No. 2019069117; and

WHEREAS, on August 18, 2022, the Council of the City of Fresno completed deliberations and took action on the West Area Neighborhoods Specific Plan and Final EIR SCH No. 2019069117; and

WHEREAS, changes to the West Area Neighborhoods Specific Plan require clerical updates to the text, policies, tables, maps, and figures contained in the Fresno General Plan.
