A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, SUPPORTING A FUTURE CITY CONTRIBUTION OF FUNDS TO FCTC SENIOR, LP FOR THE CONSTRUCTION OF WATER INFRASTRUCTURE NECESSARY TO MEET FIRE SUPPRESSION REQUIREMENTS, IN AN AMOUNT NOT TO EXCEED \$2,700,000, ASSOCIATED WITH THE FANCHER CREEK TOWN CENTER DEVELOPMENT AND AFFORDABLE HOUSING PROJECTS THEREIN

WHEREAS, in 2021, the City of Fresno (City) was awarded American Rescue Plan Act (ARPA) funding in the amount of \$170,808,029 which may be utilized for eligible expenditures, as defined by the applicable ARPA Final Rule; and

WHEREAS, the City has allocated APRA funds to support the development of permanent affordable housing; and

WHEREAS, FCTC Senior, LP (Developer) is constructing Brandhaven, a 180 unit affordable senior rental housing project within Fancher Creek Town Center (FCTC) and has requested future fiscal contributions from the City for costs associated with the construction of the water infrastructure necessary to meet fire suppression requirements for the overall construction of FCTC, including a total of 400 affordable housing units; and

WHEREAS, if eligible, the City desires to utilize unappropriated ARPA affordable housing funds to support FCTC Senior, LP in its development of affordable senior housing within FCTC; and

WHEREAS, the City's future commitment of funds for the construction of the water infrastructure necessary to meet fire suppression requirements would support completion

of the requirements necessary for the development of FCTC and the affordable housing projects to be located within FCTC.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council supports a potential future contribution of unappropriated ARPA affordable housing funds, in an amount not to exceed \$2.7 million to Developer for the construction of water infrastructure necessary to meet fire suppression requirements for the FCTC Project, including 400 affordable housing units within FCTC.

2. Any contribution of funds by the City shall be contingent upon a determination that the proposed use is an allowable expenditure and/or activity under the ARPA Final Rule.

3. Upon a determination that a contribution of funds is permissible under the ARPA Final Rule, the City Manager is authorized and directed to bring back to the City Council for its consideration a contract, subject to approval as to form by the City Attorney's Office, contributing ARPA affordable housing funds for construction of the water infrastructure necessary to meet fire suppression requirements portion of the Project.

4. This Resolution is subject to all applicable City rules and regulations.

5. This Resolution shall become effective upon final approval.
