The DPU, has identified 4,635 linear feet of existing 12-inch and 8,750 linear feet of 8-inch diameter water mains located in the area bound by West Clinton, West University, North Fruit and North Teilman Avenues that may be prone to unexpected failures due to inferior steel water mains installed in 1948 and 1958, as well as the new added flows from the new water well number 60A. The scope of work includes the replacement of the existing 8-inch and 12-inch water mains with 8-inch polyvinyl chloride pipe and 16-inch ductile iron water mains, fire hydrants, valves, and service transfers.
