A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, TO CONDUCT A TRAFFIC  
ASSESSMENT TO INCLUDE OPTIONS FOR IMPROVED  
SAFETY

WHEREAS, safe, convenient, an accessible transportation for all users is an adopted priority of the City of Fresno; and

WHEREAS, one death on our streets is one too many; and

WHEREAS, crashes that result in death or serious injury are not inevitable but largely preventable and stem in part from human inattention and speeding; and

WHEREAS, it is the role of government to do its part to serve and protect the populace; and

WHEREAS, according to the Fresno Police Department between 2017 and 2022, approximately 20,639 collisions occurred on Fresno's streets, of which 6,541 collisions resulted in injuries with a total of 9,012 injuries, resulting in 310 fatalities; and

WHEREAS, the City of Fresno is designated as a Pedestrian Safety Focus City by the Federal Highways Administration (FHWA), and

WHEREAS, the Council in partnership with the Administration desires to conduct a traffic assessment addressing the top ten intersections and to develop recommendations to combat red-light problems, speeding, collisions with pedestrians and bicyclists, and any other issues identified during the assessment.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The City shall conduct an assessment within the City of Fresno to address the top ten intersections.

2. The City Manager shall report back to the City Council with information regarding the top ten intersections, including improved public education; increased traffic enforcement; options for infrastructure improvements; potential use of traffic signal cameras (as are legally permissible); or any other means to improve motorist, bicyclist, and pedestrian safety; the Administration is hereby requested to provide a report to the Council within 75 days from the passage of this resolution.

3. This resolution shall be effective upon final approval.
