(4) applications were approved for 11M dollars. These dollars would go towards shelter operations. An agreement will go before council March 30<sup>th</sup> on tenant landlord counseling. ### **ID 23-513 Presentation by Adrienne Louis from RICV on Fair Housing Act Community Educator**

ADA Coordinator Joe Hinojosa presented on behalf of Adrienne Louis. The presentation focused on two main goals:

- 1) Prohibit discrimination in housing based on race, religion, color, and national origin.

2) Replace existing patterns of residential racial segregation.

Fair housing laws protect everyone from housing discrimination. There are other federal civil rights laws that prohibit housing discrimination when federal financial assistance is involved. Also, everyone is required to abide by the same laws. This includes landlords, rental management companies, and leasing agents. Finally, it is illegal to discriminate against any person because of race, color, religion, sex, disability, familial status, or national origin, in sale or rental housing.
