SECOND AMENDMENT TO AGREEMENT

WHEREAS, City and Consultant now desire to extend the agreement by adding three months, allowing additional time to finalize the project by June 30, 2024; and

WHEREAS, with entry into this Agreement, the Consultant agrees it has no claim, demand, or dispute against the City.

NOW, THEREFORE, the Parties agree that the Agreement be amended as follows:

- 1. The recitals to this Amendment are incorporated and made a part of the Agreement.
- 2. City shall extend the agreement by adding three months, allowing additional time to finalize the project. The new end date to be June 30, 2024.
- 3. Consultant's sole compensation for satisfactory performance of all services required or rendered pursuant to this Amendment is not modified from the original agreement.
- 4. Except as otherwise provided herein, the Agreement entered into by City and Consultant, dated July 21, 2022, remains in full force and effect.
