


Operational Statement

The proposed plan will be on Parcel number 505-070-44 which is located at 6050 W Barstow Avenue. As of right now this parcel is currently vacant and there is only dirt on this site. We are building a truck parking that could support semi-truck parking along with a truck repair shop and truck wash. There may be 5-20 employees working in the day each of their hours could be anywhere from 5-8-hour shifts. However, the shop and truck wash will not be a 24-hour facility and at night there will be one to three security guards on site to ensure safety. The parking will be usable to only designated semi-trucks most of which are projected to be living in nearby homes who will have access only with a key card or a specific gate code. The truck shop will be designed to do mainly basic services for the trucks, and nothing will be produced on site. All the parts that will be used on the trucks will be purchased or brought in off site. The truck wash will have a drain leading to a tank that will recycle the water so it can be re-used to wash the trucks. The shop is designed to be more towards the freeway as to reduce or eliminate any noise coming from the daily operations. Although the main purpose of the shop is basic maintenance, which includes but not limited to replacing parts, liquids, quick-service oil, tune-up, and brakes and mufflers. However, in the future or on occasion may include, equipment disassembly or removal or replacement of major components such as engines, drive trains, transmissions, or axles; automotive body and fender work; and vehicle painting. Future phases may include a service station which would handle retailing automotive fuels in combination of automotive repair along with providing food and other retail services. All the waste produced by the truck wash will be recycled a service company will pick up anything filtered out from the water and dispose of it.
