To The Fresno City Counsel,

I ask that the Fresno City Counsel vote No on the Outdoor Fire Resolution by Arias.

We have an unprecedented amount of Citizens who are unhoused in our community and the shelters, housing, cooling/heating centers, and other support services are unable to provide proper and timely assistance. This resolution is a violation of Basic Human Rights, especially the Right to Life and Liberty. These Rights belong to everyone not just Citizens with houses or jobs. This Right means the government should take appropriate action to protect you, this applies to Cities as well. Not being able to cook or to warm themselves places the Unhoused Citizen's health and life in danger. We have already had several Citizens lose their lives because they have nowhere to go and are forced to camp out on sidewalks where they have been hit by cars. Now you want to further decrease their chances of survival, to further place their lives at risk.

A warming fire or a grill fire does not create any more pollution than a car driving around Fresno. How many of you have fireplaces or bar-b-q grills? Arias states that he is concerned for safety, what measures has he taken to educate the Unhoused Citizens on creating safe warming fires? Has he attempted to fix some of the bar-b-q grills in the parks so that they can be used safely? Many of them are rot through. Before you deny a Citizen their Basic Human Rights you have to show that you did everything you could to help that Citizen. What has the City Counsel done? The warming centers were only open 3 days this last winter. If you pass this resolution you are infringing on Basic Human Rights of the Citizens you have sworn to serve and protect.
