The Budget Allocation for this expenditure is \$1,576,754. The contract price is 24.45 % above the Budget Allocation. If the average is greater than 10% or only one bid was received, give explanation:

The site improvements are at multiple locations within Woodward and Roeding Park. Staff believes that concurrent site mobilization and preparation at multiple locations could have potentially raised the bid amount for miscellaneous bid items. The project was initiated in April 2022 and the budget was appropriated for construction based on construction market trends from previous years. There has been an increase in materials, labor and operating cost throughout the construction industry since the project initiated. Additional funds have been appropriated to the project to account for the higher contract price.

BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

In an effort to improve the condition and accessibility of the play structures located within the City's Regional Parks (Woodward and Roeding), enhancements at four (4) different play area locations within Woodward Park: Park View, Valley View, River View and Art of Life; and two (2) different play locations within Roeding Park: Maple Grove and Pine Grove includes reconstruction of the existing paths of travel, refurbishment of parking stalls and providing site amenities that adhere to ADA accessibility standards.
