This was dictated for Russell S:

"When trying to make a decision on this. First of all, you need to experience for yourself how cold it can get out here. Come out here during the night hours one or two night and you will see how cold it is and how fires are necessary. It easy to talk when you have heating and air conditioning, but when you are out here in the elements...the weather itself ages us. We don't get very much sleep and when you can get some sleep, it basically is early morning hours when the sun is coming up. On cold nights, you can't sleep at all (And we are up watching the fire). Come out here, and you'll agree to have safe fires. Create some nice buckets that is provided by the fire department. Also provide public restrooms and other needs.
