WHEREAS, on November 20, 2014, the Department of Public Utilities presented

its Report outlining public input to its proposed water rate plan for the City of Fresno to

on the proposed water rates; and

by December 22, 2014, and held a public hearing on February 5, 2015, as required by

Proposition 218 (Cal. Const. Art. XIIID, § 6); and

WHEREAS, the Notice of Public Hearing instructed property owners of record

and ratepayers of record on how to file a protest to the proposed water rates, in

accordance with Proposition 218; and

WHEREAS, the proposed water rates will be used to fund capital projects, debt

obligations, reserves, and costs for operating and maintaining current service levels

within the service areas, as prescribed by Proposition 218; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno that based upon the information and testimony presented at the Public Hearing on February 5, 2015, and the City Council meeting on February 26, 2015, Council hereby:

- 1. Adopts the proposed five-year water rate plan; and
- 2. Directs staff to update the Master Fee Schedule in accordance with the effective rates adopted as part of this Resolution.
