A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING SUBSTANTIAL AMENDMENT NO. 2015-004 TO THE FY 2014-2015 ANNUAL ACTION PLAN AUTHORIZING \$200,000 OF HOME INVESTMENT PARTNERSHIPS COMMUNITY HOUSING DEVELOPMENT ORGANIZATION (HOME-CHDO) FUNDS TO HABITAT FOR HUMANITY FRESNO COUNTY, INC., FOR THE AVENUE/EFFIE STREET SINGLE-FAMILY HOUSING PROJECT AND AUTHORIZE THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD AND APPROVED AS TO FORM BY THE CITY ATTORNEY

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires jurisdictions that receive federal entitlement program funds to prepare an Annual Action Plan, which identifies the projects to be funded with HOME Investment Partnerships (HOME) Program, Community Housing Development Organization (CHDO) Funds; and

WHEREAS, the City of Fresno (City) previously adopted the FY 2014-2015

Annual Action Plan on June 19, 2014; and

WHEREAS, the proposed amendment is consistent with the five-year Consolidated Plan, which the City Council adopted on May 13, 2010; and

WHEREAS, the thirty-day public review and comment period concluded March 26, 2015; and

WHEREAS, the City desires to submit a Substantial Amendment to its FY 2014-2015 Annual Action Plan (Exhibit "A") to HUD to include a CHDO project funded with HOME CHDO funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The above recitals are true and correct and incorporated herein.
- 2. The Council of the City of Fresno, California, approves submission of the attached Substantial Amendment No. 2015-004 to FY 2014-2015 Annual Action Plan to include a new CHDO project to be funded with HOME CHDO funds.
- 3. The City Manager is authorized to sign all reasonably required or implicated documents, instruments, and funding agreements in pursuit hereof, subject to prior approval as to form by the City Attorney's Office.

SUMMARY

The City of Fresno is a federal entitlement community that receives an annual allocation of HOME Investment Partnerships (HOME) Program funds from the U.S. Department of Housing and Urban Development (HUD). As an entitlement community, the City is required to prepare an annual action plan detailing the uses of HOME funds to meet housing goals as outlined in the 2015-2019 Consolidated Plan. As a recipient of HOME Program funds, the City is required to set aside a portion of funding specifically for Community Housing Development Organization (CHDO) projects.

For fiscal year 2014-2015, the City selected Habitat for Humanity, a city-certified CHDO, to receive funding for two single-family housing projects. On June 19, 2014, at the adoption of 2014-2015 Annual Action Plan, the project had not yet been identified. Therefore the City proposes, at this time, to substantially amend the FY 2014-2015 Annual Action Plan as follows:

Include Habitat for Humanity Lotus/Effie Single-Family Housing Project to be funded with HOME CHDO funds in the amount of \$200,000.

Habitat's Lotus/Effie project is determined to be a new use of funds and differs from those projects originally approved as part of the 2014-2015 Annual Action Plan. The proposed addition is substantial and requires a 30-day public review and comment period. This Substantial Amendment No. 2015-004, will be made available for public review and comment on February 26, 2015 through March 27, 2015.


