RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO,
CALIFORNIA, TO SUBMIT GRANT APPLICATIONS TO
FRESNO COUNCIL OF GOVERNMENTS REGIONAL
SURFACE TRANSPORTATION PROGRAM AND
AUTHORIZING THE EXECUTION OF DOCUMENTS BY THE
PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, AB1012 has been enacted into State Law in part to provide for the
“timely use” of state and federal funding;

WHEREAS, the City of Fresno is able to apply for and receive federal and state
funding under the Federal Surface Transportation Act;

WHEREAS, the City of Fresno desires to ensure that its projects are delivered in
a timely manner to preclude the Fresno Region (“Region”) from losing those funds for
non-delivery;

WHEREAS, it is understood by the City of Fresno that failure for not meeting
project delivery dates for any phase of a project may jeopardize federal or state funding
to the Region;

WHEREAS, the City of Fresno can demonstrate dedicated and available local
matching funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as
follows:

1. The Council agrees that all project delivery deadlines for all project phases
will be met or exceeded;
2. The Council finds that failure to meet project delivery deadlines may be
deemed as sufficient cause for the Fresno Council of Governments Policy Board to

terminate an agency's project and reprogram federal and state funds as deemed necessary;

3. The Council directs the City Manager and the City Engineer to ensure that all projects are carried out in a timely manner consistent with the requirements of AB 1012 and the directive of the City Council;

4. The Council appoints and authorizes the Public Works Director, or designee, as the agent for the City to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, payment requests and so on which may be necessary for the completion of the aforementioned projects, subject to prior approval as to form by the City Attorney's Office.
