Containing an area of 9,076 square feet, more or less.

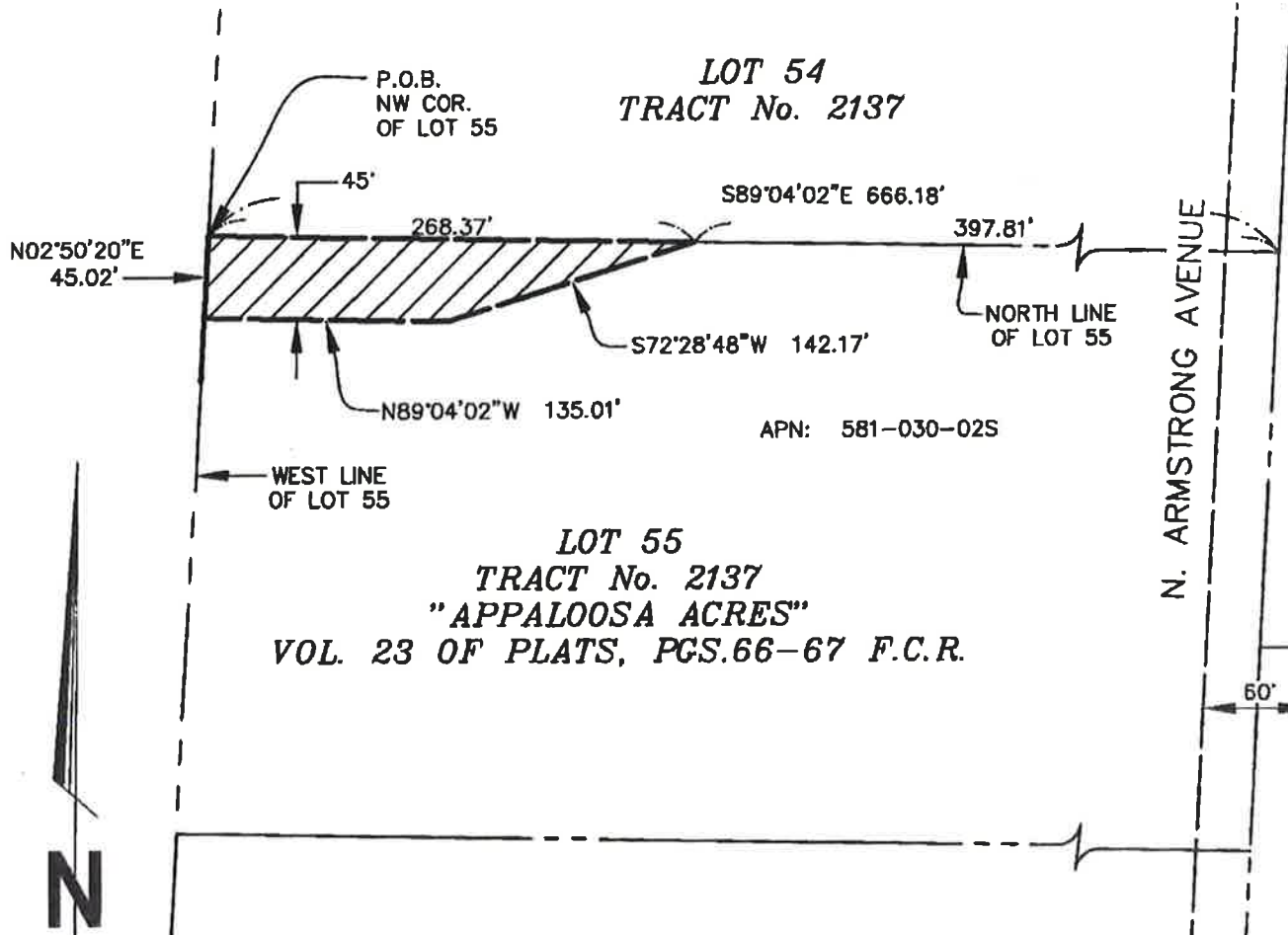



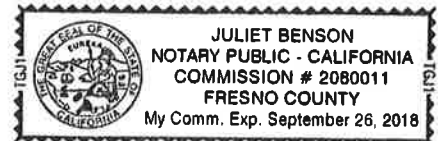
