WHEREAS, Fresno Council of Governments announced the availability of funding through its Regional Competitive Active Transportation Program ("RCATP") grant funding cycle;

WHEREAS, the City will enter into an agreement with the Fresno Council of Governments for the development of projects;

1. Approves the applications for and acceptance of grant funding from the Cycle 2 RCATP grant program from the Fresno Council of Governments and participation therein, consistent with constitutional and local law requirements and this resolution;
