

ADDITIONAL SCOPE OF WORK

City of Fresno staff requested that FirstCarbon Solutions (FCS) evaluate the current status of the DNCP/FCSP EIR in terms of additional evaluations required due to the approval of Fulton Mall and the recent approval of the Fresno General Plan and certification of the Master EIR. FCS temporarily stopped work on the EIR in September 2013 due to a City decision to proceed with the preparation of the Fulton Mall EIR and complete the General Plan Update and Master EIR prior to resuming the preparation of the DNCP/FCSP EIR. The removal of the Fulton Mall from the DNCP/FCSP as well as the completion of the General Plan Update and Master EIR priors to the DNCP/FCSP EIR. The removal of the Fulton Mall from the need for various revisions to the DNCP/FCSP EIR. Following is the scope of work to augment the original contract with the City of Fresno entered into in November 2012 to complete these revisions.

Task 1: Project Initiation/Organization

FCS will re-start the preparation of the DNCP/FCSP. This task includes a review of the current version of the DNCP/FCSP EIR to determine revisions that are needed due to the preparation of a separate EIR for the Fulton Mall as well as the recent approval of the General Plan Update and certification of the Master EIR. This task also includes participation of up to three conference calls to reinitiate the preparation of the EIR. Furthermore, this task includes communications among various project team members regarding the required revisions. This task also includes re-issuance of the NOP.

Task 2: Introduction

This section will need to be revised to re-categorize the type of environmental document that will be prepared. The environmental document will no longer be a combined Program/Project EIR and will be revised to a Program EIR.

Task 3: Executive Summary

The Executive Summary includes a description of the Proposed Project, and this description will need to be revised based on changes identified below.

Task 4: Project Description

Due to the approval of the Fulton Mall project and its EIR as well as the approval of the General Plan Update, its Master EIR, and the new Development Code, various revisions to the project description for the DNCP/FCSP will be required. These would include, but not be limited to, remove references to the Fulton Mall, update reference to required approvals, revise discussion related to the Fresno Municipal code to reflect the new Development Code, clarify description of specific land uses in accordance with the updated General Plan.



Task 5: Air Quality/GHG Reports

The policy discussion from the 2025 General Plan will need to be revised to reflect the General Plan Update policies. The analysis will need to be revised to ensure consistency with the analysis in the Master EIR. Additionally, based on updates to the traffic study for the traffic analysis to be conducted by Fehr and Peers, new modeling will need to be conducted, which will require changes to the analysis in the air quality and GHG reports.

Task 6: Noise Report

The noise analysis will need to be revised to reflect the change in the noise thresholds as well as the new noise policies provided in the General Plan Update. The analysis will need to be revised to ensure consistency with the analysis in the Master EIR. Additionally, based on updates to the traffic study for the traffic analysis to be conducted by Fehr and Peers, new modeling will need to be conducted, which will require changes to the analysis in the noise report.

Task 7: EIR Issue Discussion

Following are key revisions needed for other environmental issues.

- The discussion of air quality discussion needs to be revised to be generally consistent with the General Plan Update revisions. These revisions include discussions of criteria pollutants as well as cumulative effects. The section will also be updated to reflect the findings of the new modeling data.
- 2. The greenhouse gas discussion within the EIR will need to be revised to be consistent with the Greenhouse Gas Reduction Plan discussion in the General Plan Update EIR. The section will also be updated to reflect the findings of the new modeling data.
- 3. FCS will incorporate information from the final versions of the Phase I reports (FCSP and DNCP) from Krazan.
- 4. The policy discussion in the land use section will need to be revised to address the policies within the General Plan Update.
- 5. The noise discussion will need to be revised to reflect the change in the noise thresholds as well as the new noise policies provided in the General Plan Update and new Development Code, as necessary. The section will also be updated to reflect the findings of the new modeling data.
- 6. The traffic discussion regarding existing policies need to be revised from 2025 General Plan policies to General Plan Update policies. The section will also be updated to reflect updates to the traffic study.





Task 8: Compile Administrative Draft EIR

With the above revisions, additional compilation of the discussions and analyses of each environmental issue will need to occur.

Task 9: Project Management/Coordination

Due to the approximately 1.5-year delay, additional project management and coordination will need to occur during the preparation of the Program EIR.

Assumptions

The assumptions used in calculating the above fees are:
