FOURTH AMENDMENT TO AGREEMENT

THIS FOURTH AMENDMENT TO AGREEMENT ("Amendment") made and entered into as of this _____ day of September 2015, amends the Agreement heretofore entered into between the CITY OF FRESNO, a municipal corporation, hereinafter referred to as "CITY", and CH2M HILL Engineers, Inc., a Delaware corporation, hereinafter referred to as "CONSULTANT". CITY and CONSULTANT are collectively referred to as Parties.

RECITALS

WHEREAS, CITY and CONSULTANT entered into an Agreement, dated October 31, 2013, for professional program management services for Metropolitan Water Resources Management Plan including CIP and Operational System Improvements, hereinafter referred to as "Agreement"; and

WHEREAS, the Agreement was amended on August 5, 2014 to extend the

Agreement through July 31, 2014 ("1st Amendment"); and

WHEREAS, the Agreement was amended on August 5, 2014 to fund CONSULTANT services to be performed during Fiscal Year 2015 (July 01, 2014 through June 30, 2015) for continued professional program management services for the Metropolitan Water Resources Management Plan including CIP and Operational System Improvements ("2nd Amendment"); and

WHEREAS, the Agreement was amended on June 19, 2015 to fund CONSULTANT services to be performed during Fiscal Year 2016 (July 01, 2015 through June 30, 2016) for continued professional program management services for the Metropolitan Water Resources Management Plan including CIP and Operational System Improvements ("3rd Amendment"); and

WHEREAS, Agreement states that compensation for services required or rendered during subsequent fiscal years will be determined annually based upon the level of effort required for services during each subsequent fiscal years, subject to approval by the Director of Public Utilities; and

WHEREAS, CITY and CONSULTANT desire to increase compensation in order to fund additional CONSULTANT services to be performed during Fiscal Year 2016 (July 01, 2015 through June 30, 2016) for continued professional program management services for Metropolitan Water Resources Management Plan including CIP and Operational System Improvements.

AGREEMENT

In consideration of the above recitals, which recitals are contractual in nature, the mutual premises herein contained, and for other good and valuable consideration hereby acknowledge, the Parties agree that the aforesaid Agreement be amended as follows:

1. CONSULTANT'S sole compensation for satisfactory performance of all services required or rendered during Fiscal Year 2016 (July 01, 2015 through June 30, 2016) pursuant to the Agreement shall be increased by \$1,140,000 to a total fee not to exceed \$8,240,000 paid on a time and material basis with mark-up in accordance with the schedule of fees contained in the Agreement.

- 2. In the event of any conflict between the body of this Amendment and any Exhibit or Attachment hereto, the terms and conditions of the body of this Amendment shall control and take precedence over the terms and conditions expressed within the Exhibit or Attachment. Furthermore, any terms or conditions contained within any Exhibit or Attachment hereto which purport to modify the allocation of risk between the Parties, provided for within the body of this Amendment, shall be null and void.
- 3. Except as otherwise provided herein, the Agreement, 1st Amendment, 2nd Amendment, and 3rd Amendment entered into by CITY and CONSULTANT, remain in full force and effect.
