LEASE AMENDMENT NO. 2

to the

AVIATION LAND AND LEASE AGREEMENT

Between

CITY OF FRESNO, CALIFORNIA

And

THE STATE OF CALIFORNIA (MILITARY DEPARTMENT)

THIS LEASE AMENDMENT NO. 2 is made and entered the __ Day of ____, 2016, by and between the CITY OF FRESNO, CALIFORNIA, a municipal corporation (hereinafter referred to as "Lessor") and THE STATE OF CALIFORNIA ARMY NATIONAL GUARD AVIATION CLASSIFICATION REPAIR ACTIVITY DEPOTS (AVCRAD), located at 5168 East Dakota Avenue, Fresno, California 93727, (hereinafter referred to as "Lessee").

RECITALS

WHEREAS the Parties entered into a Lease Agreement effective August 17, 1993, (the "Agreement") covering a 23.7169 +/- acres at the Fresno Yosemite International Airport, and

WHEREAS the area of the Agreement was amended by Amendment No. 1 and four parcels were added resulting in an increased rental area of approximately 45 acres, and

WHEREAS Lessee desires to relinquish Parcel No. 4 (approximately 20,075 sq. ft.) of Amendment No. 1; and

WHEREAS Lessee desires to enter into an agreement with The CALIFORNIA AIR NATIONAL GUARD (CANG) to allow a safety radius of its munitions storage area to encroach onto the Lessee's leasehold area.

WHEREAS Lessor has determined it is in its best interest to allow Lessee to relinquish Parcel No. 4 of this Agreement with Lessee.

WHEREAS Lessor has determined it is in its best interest to allow Lessee to enter into such agreement with CANG.

NOW, THEREFORE, in consideration of the foregoing recitals and of the mutual promises herein contained, the Parties hereby agree as follows:

- Exhibit 2-A of the Amendment No. 1 to Aviation Land Lease and Agreement, "Legal Description Fresno Air Terminal State of California Adjutant General AVCRAD and AAFA Lease site" shall be replaced with Exhibit 2-B as attached
- 2. Section 10-a. Hypothecation, Assignment and Subleasing of the Aviation Land Lease and Agreement shall be amended and replaced with:
 - a. GENERAL: Nothing in this Lease shall be deemed to allow State, either voluntary by operation of law, to hypothecate, encumber, sell, assign, surrender, or otherwise transfer this Lease, in whole or in part; or to hypothecate, encumber, sell, assign, surrender, or otherwise transfer, in whole or in part, any of State's rights, title and interests in or to any part or all of the leased premises and/or in or to any art or all of the improvements and appurtenances which existed therein or thereon at the commencement of the thereof or which may, at any time and from time to time, be constructed or installed therein or thereon during the life hereof; or to rent, sublet or otherwise permit/allow/suffer occupancy and/or use of any part or all of the leased premises by any person or entity other than State and State's personnel, employees, agents, representatives, and invitees without the expressed written consent of the City of Fresno Director of Aviation.

State confirms, acknowledges, and/or agrees that Lessor has been induced to enter into this Lease with State for reasons which include, but are not limited to, the obtaining of the unique benefits of the state's presence on Airport as an aviation lessee of Lessor and that the prohibition against hypothecation, assignment, and subleasing set forth within subparagraph lob, below, is consistent therewith and is expressly agreed to by State.

3. Except as expressly provided in this Amendment No. 2, all other terms and provisions of the Agreement shall continue in full force and effect.
